ROLL CALL

FIRE DEPARTMENT REQUISITION

UTILITY DEPARTMENT

Jason Myers presented to the council to change the tree dump opening times to 1st and 3rd Saturdays of the month 8am to 10am. Every Wednesday tree dump will remain open from 4pm to 5pm. Lay motion to change to the 1st and 3rd Saturday's, Barnes seconded. 4/0. Jason priced new street signage – this was put on hold to find out if ARPA fund can be used to purchase street signage. Lake dock has been updated with new composite boards.

OLD BUSINESS

Lay made the motion to proceed with 3-mile extra territorial zoning. Barnes seconded. All in favor 4/0

NEW BUSINESS

New health insurance will change to BCBS of KS January 1, 2025. Lay motion to approve new health insurance plan, Barnes seconded. Motion carried 4/0.
