**CALL TO ORDER:**

Also, present were Lea Hilderbrand Interim City Clerk, Jason Myers Maintenance Department Superintendent, Terrie Wiley Interim Treasurer, and Joe Kashka representing the fire department.

**MINUTES** Barnes made a motion to accept the minutes of the December 11, 2024 special meeting. Lay seconded. Motion carried 4/0.

**MINUTES** Simmons made a motion to accept the minutes of the December 24, 2024 amended budget hearing. Lay seconded. Motion carried 4/0.

**INVOICES** Barnes made a motion to pay invoices in the amount of \$43,490.80. Lay second. Motion carried 4/0.

**CITIZENS TO BE HEARD**

The Labette County Emergency Manager, Charlie Morse was to go over the hazard mitigation plan. He was unable to come due to inclement weather. And is rescheduled for the February meeting. Zed Goodwin and Zack Townsend were to discuss the old Donnally property that is now up for sale, and their ability to have access to city water. They were also not able to make it due to weather conditions.

**CITY CLERK**

Lea reported that ALLPAID, has raised its service fee that it charges customers to \$3.99 per transaction.

## **FIRE DEPARTMENT**

Joe Reported that the Brush Truck #2 needs 4 new tires and were priced at \$905 from Miller tire. Simmons motioned; Barnes seconded. 4/0

New applicant Whyatt Moore to be approved pending background check. Barnes motioned and Simmons seconded, motion passed 4/0

Fire suburban to be classified as surplus and placed up for auction. Would like to take sealed bids in February. Would be posted on Facebook and in Labette Ave. Lay motioned, Barnes seconded, motion passed 4/0.

Lea was voted in as new treasurer for the fire department.

Also, the handheld radios that were sent off to be repaired are fixed and returned.

## **UTILITY DEPARTMENT**

Jason Myers proposed to raise the RW #8 rate to \$5.00 per 1,000 gal. In order to match the purchase rate at Public Wholesale #4. Lay made a motion to approve the raise, Barnes seconded, Passed 4/0

Kansas Rural Water Association conference to be held in Wichita March 25-27<sup>th</sup>. Jason and Terrie would both like to attend with expenses estimated at around \$1,200. Barnes made a motion, Lay seconded and motion passed 4/0.

New batteries were obtained for the sirens, totaling \$605. The repairman is also scheduled to come out Tuesday 1/14/25. Barnes motioned, Lay seconded and motion passed 4/0.

Danny Triebel was able to fix the hydraulic leak on the backhoe, the bill totaled \$400.00

TC Underground is done with their work in town. Also, a call has been put in to Curtis Short at Atmos about the broken water line at 108 N Walnut. We have not heard back.

Next month we will be looking to replace filters on all trucks and equipment.
