## ORDINANCE NO. 348

AN ORDINANCE RELATING TO PEACE, GOOD GOVERNMENT AND GENERAL WELFARE.

BE IT ORDAINED BY THE MAYOR AND COUNCILMEN OF THE CITY OF EDNA, KANSAS:

- SECTION 1. Any person who shall assault, beat, or wound another, shall on conviction thereof be fined not to exceed five hundred (500.00) dollars.
- SECTION 2. Any person who shall obstruct, resist or oppose any City Officer in the discharge of his or her duty, shall on conviction there of be fined not exceeding one hundred (100.00) dollars.
- SECTION 3. Any person not being an officer or traveler who shall carry any firearms, knives, (except pocket knives) sling shots or other deadly weapons concealed within said City, shall be fined in any sum not exceeding twenty-five (25) dollars.
- SECTION 4. Any person, except law enforcement, twenty one years of age found carrying any deadly weapon concealed or otherwise, shall be deemed guilty of an offense and on conviction thereof shall be fined in any sum not exceeding twenty-five (25) dollars. Providing this not to apply to any one leaving town on a hunting expedition or returning there from.
- SECTION 5. Whoever willfully disturbs the peace and quiet of the City or any neighborhood, family or person herein by loud, unusual noise, tumultuous conduct, vulgar or offensive language, quarrelling, fighting, challenging to fight on displaying firearms or other deadly weapons, shall be deemed guilty of an offense, and on conviction be fined not exceeding fifty (50.00) dollars.
- SECTION 6. Whoever willfully disturbs any assembly of people met for a lawful purpose by improper conduct shall be deemed guilty of an offense and on conviction there of be fined in any sum not exceeding two hundred (200.00) dollars.

- Except for sports events or practices,
  Whoever discharges any firearms or throws any
  stones or missiles by the hand or by means of
  any device held there in within the corporate
  limits of the City of Edna shall be guilty of
  an offense and on conviction thereof be fined
  in any sum not exceeding one hundred (100.00)
  dollars.
- SECTION 8. Whoever shall break, mar, deface, injure, or destroy any property, public or private, real or personal not his own within the City of Edna shall be deemed guilty of an offense and on conviction thereof be fined in any sum not ex-exceeding one hundred dollars and pay restitution.
- SECTION 9. Any person who shall be found drunk or intoxicated or who shall be guilty of any disorderly conduct on any public street, or in any public place within the city shall be deemed guilty of an offense and on conviction be fined in any sum not exceeding twenty-five (25) dollars.
- SECTION 10. All ordinances in conflict herewith are hereby repealed.
- SECTION 11. This ordinance shall be in full force and effect after its publication in the official city news paper.
